

# GUIDE TO COMPLETING THE FORM



You can also apply online at [www.plr.uk.com](http://www.plr.uk.com) or print a form via our website under Registration Service/PLR Forms & Leaflets. Forms can be provided in braille or large print on request.

## New PLR Applicants:

Please complete all sections apart from the PLR No which will be allocated when your form is processed.

**A** You should complete this section using your real name. Writing names should be listed under Section F (Book Details). At the time of application, your principal home must be in the UK or any of the countries within the EEA (EC Member States plus Norway, Iceland & Liechtenstein). Further information is available in Section 2 of our Information Leaflet and on our website under Registration Service/PLR Forms & Leaflets.

**B Payments within the UK:** To save costs, payment is made by credit transfer direct into your account. If the account is with a building society, please check with the branch to find out which details need to be quoted.

**Payments outside the UK:** To save costs, earnings are paid by cheque in Euros. Payments will be converted to Euros from Sterling at the rate that applies on the day on which they are paid from PLR's bank account. You may leave this section blank unless you wish to nominate a UK bank account to receive your payments (in Sterling).

**C** Applications cannot be processed unless this section is signed by the applicant.

**D** Required only on your first application for PLR. This section should be completed by an independent witness who is not a relative and who has known you for at least two years.

**E** Required only on your first application for PLR. Please indicate which documents you are providing. The attached sheet details which documents are acceptable to support your application. Information is also available on our website under Registration Service/PLR Forms & Leaflets.

**F** List details of your published books and any writing names you may have used for the titles which you are applying to register. Refer to the example page overleaf for further information.

**Contributor** List each contributor named on the title page (including yourself) and identify the nature of contribution eg writer, illustrator, editor.

**% Share** Please see Section 2 of our Information Leaflet for details of eligible contributors and shares. Information is also available on our website under Registration Service/PLR Forms & Leaflets.

**Publ'n Year** The month of publication is only required for books published in the year that you apply.

**ISBN** The ISBN (International Standard Book Number) is a 10 or 13 digit number printed on the reverse of the title page or the cover. (NB since Jan 2007 all new books have 13 digit ISBNs.) Each edition of a book (eg hardback, paperback, large print) has a different ISBN and must be listed separately. **However, reprints, where the ISBN does not change, should not be listed.**

## Additional Book Registrations:

- Enter your PLR number in the box at the top of the page.
- Always complete the **shaded areas** of **Sections A & C**. If any of your details have changed, please write the new information in capitals on the form.
- If you only want to advise us of an amendment to your personal or bank details and you do not wish to register additional books, you can do so in writing or via the online service ([www.plr.uk.com](http://www.plr.uk.com)). We can accept changes of address (but not bank) over the telephone, subject to verification. Please note that we are unable to accept changes to either address or bank details via email.
- You **do not** need to complete the Certificate (Section D) or provide Supporting Documents (section E).
- You **do not** need to re-apply for ISBNs which are already on the Register.

# IMPORTANT NOTICE

## SUPPLEMENTARY INFORMATION REQUIRED FOR NEW APPLICANTS

In order to comply with government authentication guidelines, first-time applications for PLR must also be accompanied by any **TWO** documents from the following lists:-

You may provide two separate items from the same category ie two bills from different providers.

***Please note that original documentation must be provided, not copies. All documents will be processed in accordance with the Data Protection Act and returned after we have recorded receipt, usually within one working week. No identification data will be stored by PLR.***

- Gas or electricity bill dated within the last six months
- Land-line telephone bill dated within the last six months
- Certificate from supplier of utilities confirming arrangement to pay for services on pre-payment terms (covering current period)
- Council tax or water bill, valid for the current year
- Bank, building society or credit card statement (excluding statements downloaded from the Internet) dated within the last six months
- Most recent Mortgage statement from a recognised lender

If you are unable to provide any of the documents listed above, the following items are also acceptable:-

***These documents will be returned to you by recorded delivery.***

- Current local council rent card or tenancy agreement
- Benefit payment book or notification letter from the Benefit Agency confirming the right to benefits for current period (if not used for evidence of name)
- Current UK photo-card driving licence
- Current full old style driving licence
- Building society passbook containing current address

Please note that these lists are not exhaustive. If you do not have any of the documents listed above, you can provide any other formal document which details your name and address.
